## Experts in Scholarship & Fellowship Management

IIE's scholarship and fellowship management expertise and systems are unmatched due to its experience implementing large and small-scale in-country, third country, and U.S.-based programs.

With local partners, IIE provides USAID Missions worldwide with input into the design, evaluation, and implementation of a range of scholarship and fellowship activities including: participant recruitment and academic placement (including outreach to minorities, people with disabilities, and remote areas), participant monitoring and support, implementation of enrichment and professional development activities, technical assistance for short-term trainings and study tours, performance assessments, and performance solutions.

Throughout their scholarship or fellowship, IIE provides participants with extensive support and mentoring to ensure they meet academic and program requirements while maintaining a focus on their mental health and cultural adaptation. IIE partners with and builds the capacity of local partners whose local knowledge and experience complements IIE's expertise. With local partners, IIE has:

- Recruited over **84,318** in-country and third-country **participants** from diverse geographic and socioeconomic backgrounds
- Developed new in-country **alumni and participant networks** such as ALPHA-I in Indonesia, an organization of over 541 PRESTASI alumni that is empowering Indonesia's future leaders
- Implemented the USAID/Burma Lincoln Scholarship Program, which was expanded from 95 to 135 scholars during COVID-19 and ongoing civil unrest. Has focused on **continuous adaptation, emergency management**, and support to staff and scholars experiencing trauma.
